

Further the Chairman (Academic Council), requested Dr. Anurag Choubey to place the agenda for discussion.

AC/51/01: To Confirm the Minutes of 50th Meeting of the Academic Council held on 20/12/2021.

The Chairman welcomed all the learned members of the Academic Council specially the members from outside, who attended the meeting. He requested the Director to present the agenda items for deliberation.

AC/51/02: Budget utilization of Financial Year 2021-22

The council reviewed the budget utilization of Financial Year 2021-22 up to March 2022. The council expressed satisfaction on the utilization of budget up to March 2022 for the year 2021-22.

The Council noted and approved the agenda Item.

AC/51/03: Budget Proposal for the Current Academic Year 2022-23.

The Convener presented the budget to the council for review and approval. The council reviewed the budget proposals submitted by all the concern departments of the institute. All the members have shown the satisfaction on the amount of budget and unanimously approved the annual budget of Rs. 32.54 Cr. for the year 2022-23.

The resolution forwarded to the Governing Body for approval and ratifications.

AC/51/04: To introduce new courses in engineering and technology at UG/PG level.

The Academic council proposed to introduce new UG course in Computer Science and Engineering (Artificial Intelligence), increase in intake of Computer Science and Engineering (Data Science) from 60 to 180 seats and CSE (AIDS) from 60 to 120 seats, also recommended to reduce seats in Mechanical Engineering 120 to 60 seats, Electronics and Communications 120 to 60 seats. All the members of Governing Body expressed satisfaction and ratified the proposals.

Resolution: The resolution may be forwarded to the Governing Body for consideration and ratifications.

AC/51/05: To Review the Compliance Report Progress of All the Three Departments.

The council reviewed the progress of compliance status for the said departments in the perspective of last compliance issued by NBA and it is decided that the departments should do this work on priority basis. The council members also agree to review the progress weekly and report the status of progress to Dr. Anurag Choubey.

Resolution: The resolution may be forwarded to the Governing Body for consideration and ratifications.

AC/51/06: To Review the Library Requirements and Facilities.

Convener presented the Library requirements as per the introduction of new courses and increase intake of various departments before the council and shared the recommendations given by each department of the institute. He suggested increasing the books and journal as per requirements in the each department. The members of Academic Council unanimously approved the requirements.

AC/51/07: Review of progress on faculty research and support system.

The Convener presented the approval of Academic Council to adopt faculty research and support system to promote research and activities more effectively. The members of Governing Body unanimously approved and ratified the requirements.
