The point wise agenda discussed is as follows:

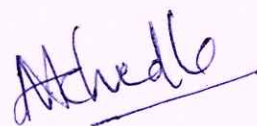
Agenda 1: Formulation and approval of the proposed academic rules and regulations (ARR) for the effective execution of the autonomy by the institution.

Discussion: Chairman of the Academic Council apprised all the members that as per Clause - 13 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023 has been referred and the ARR has been frame accordingly. Salient points of the ARR focusing mainly on academic Calander, course structure, examination, award of the degree, merit list, minor and major courses, re-examination, performance improvement and attendance etc. have been shared.

Resolution: *All the members of council unanimously agreed to incorporate short answer and medium answer questions in place of multi choice questions in end semester exam as mentioned in the Section 10.6.1(Pg. No. 18). Members in principal approved proposed ARR and agreed to go through the proposed ARR for any modification (if required).*

Agenda 2: Nomination of 2 subject experts in Board of Studies from outside the parent university in the department of CSE & Allied (B.Tech.), IT (B.Tech.), M.Tech. (CSE), MCA, Electronics & Communication Engg. (B.Tech. and M.Tech.), Electrical & Electronics Engg. (B.Tech. and M.Tech.), Mechanical Engg. (B.Tech and M.Tech.), Civil Engg. (B.Tech.), Science & Humanities (Physics, Chemistry, Mathematics and Humanities).

Resolution: *The council reviewed the proposed nomination of the subject experts. They advised to incorporate the subject experts from the different institutions (preferably) in the respective Board of Studies. The council members further suggested that the institute may incorporate one member in every BOS to be from industry/field.*



Agenda 3: Revision of academic calendar of B.Tech. - 6th, 4th, 2nd semester and M.Tech. (2nd)/MCA(2nd) semester for the academic session 2024 - 25.

Resolution: *It was unanimously resolved to adopt the proposed academic calendar of B.Tech. - 6th, 4th, 2nd semester and M.Tech./MCA- 2nd semester for the academic session 2024 - 25.*

Agenda 4: Proposal to conduct the May – June 2025 examination and re-examination of all the enrolled students in RGPV of all the courses including M.Tech dissertation by Technocrats Institute of Technology, Bhopal following the same scheme, syllabus and pattern as prescribed by RGPV.

Resolution: *It was unanimously approved to conduct the May – June 2025 (current session) examination and re-examination of all the enrolled students in RGPV of all the courses including M.Tech. dissertation by Technocrats Institute of Technology, Bhopal following the same scheme, syllabus and pattern as prescribed by RGPV.*

Agenda 5: Proposal to frame new scheme and syllabus of I year of all the courses (under RGPV) for the 2025 admitted batch of students.

Resolution: *The Academic Council advised to formulate the frame work of the proposed scheme of all the courses/semesters and syllabus of I year of all the courses (under RGPV) for the 2025 admitted batch of students. The scheme needs to be prepared for all the semester of all the courses and recommended through BOS for approval from Academic Council.*
