The point wise agenda discussed is as follows:

Agenda 1: Introduction of Hon'ble Governing Body members and brief Institutional Information.

Decision taken to conduct the May–June 2025 examination and re-examination of all the enrolled students in RGPV of all the courses including M.Tech dissertation by Technocrats Institute of Technology, Bhopal following the same scheme, syllabus and pattern as prescribed by RGPV. - c. Proposal to frame new scheme and syllabus of I year of all the courses (under RGPV) for the 2025 admitted batch of students. (Agenda No. 5 of AC)

Agenda 3: To discuss and frame other polices for implementation of the autonomy.
